4. Withdrawal and Termination of Membership (Bylaw Summary)

I acknowledge the following, as set out in the Co-operative's bylaws:

Voluntary Withdrawal (Bylaw 3.02)

- I may withdraw my membership by providing one month's written notice to the Board.
- If I move out of the trading area, file for bankruptcy, or pass away, this will be treated as a withdrawal upon satisfactory proof to the Board.

Termination of Membership (Bylaw 3.03)

- My membership may cease by:
 - Approval of my withdrawal by the Board; or
 - A special resolution of the Board to terminate my membership.
- If my membership is terminated:
 - I will be notified in writing within 10 days of the Board's decision.
 - I may appeal the termination by giving written notice to the Secretary within 30 days of receiving the termination order.
 - The appeal will be heard at the next Members' meeting, where Members may rescind the termination by majority vote.
 - If not resolved, I may further appeal to the Registrar under the applicable legislation.
